# INTRODUCTION

This document (the "GUIDELINE") is to be used as a guideline with regard to the composition, calculation and maintenance of the Solactive ISS US Low Carbon Leaders ex-Fossil Fuel Index (the "INDEX"). Any amendments to the rules made to the GUIDELINE are approved by the OVERSIGHT COMMITTEE specified in Section 5.5. The INDEX is owned, calculated, administered and published by Solactive AG ("SOLACTIVE") assuming the role as administrator (the "INDEX ADMINISTRATOR") under the Regulation (EU) 2016/1011 (the "BENCHMARK REGULATION" or "BMR"). The name "Solactive" is trademarked.

The text uses defined terms which are formatted with "SMALL CAPS". Such Terms shall have the meaning assigned to them as specified in Section 6 (Definitions).

The Guideline and the policies and methodology documents referenced herein contain the underlying principles and rules regarding the structure and operation of the INDEX. Solactive does not offer any explicit or tacit guarantee or assurance, neither pertaining to the results from the use of the INDEX nor the level of the INDEX at any certain point in time nor in any other respect. Solactive strives to the best of its ability to ensure the correctness of the calculation. The INDEX is published on the website of the INDEX ADMINISTRATOR (<a href="www.solactive.com">www.solactive.com</a>) and is, in addition, available via the price marketing services of Boerse Stuttgart GmbH and may be distributed to all of its affiliated vendors. Each vendor decides on an individual basis as to whether it will distribute or display the INDEX via its information systems.

#### 1.3. INITIAL LEVEL OF THE INDEX

The initial level of the Price Return version of the INDEX on the 03/02/2011, the START DATE, is 1000. Historical values from the 3/05/2016, the LIVE DATE, will be recorded in accordance with Article 8 of the BMR.



# 1.4. PRICES AND CALCULATION FREQUENCY

The level of the Underlying Index is calculated on each Calculation Day from 9:00 a.m. to 4:30 p.m. EST based on the Trading Prices on the Exchanges on which the Index Components are listed. Trading Prices of Index Components not listed in the Index Currency are converted using the current Intercontinental Exchange (ICE) spot foreign exchange rate. Should there be no current Trading Price for an Index Component, the later of: (i) the most recent Closing Price; or (ii) the last available Trading Price for the preceding Trading Day is used in the calculation.

In addition to the intraday calculation a closing level of the UNDERLYING INDEX for each CALCULATION DAY is also calculated. This closing level is based on the CLOSING PRICES for the INDEX COMPONENTS on the respective EXCHANGES on which the INDEX COMPONENTS are listed. The CLOSING PRICES of INDEX COMPONENTS not listed in the INDEX CURRENCY are converted using the 04:00 p.m. London time rates provided by WM/Refinitiv (the "WM/Refinitiv Rate"). If there is no 04:00 p.m. London time WM/Refinitiv Rate for the relevant CALCULATION DAY, the last available 04:00 p.m. London time WM/Refinitiv Rate will be used for the closing level calculation.

#### 1.5. LICENSING

Licenses to use the INDEX as the underlying value for financial instruments, investment funds and financial contracts may be issued to stock exchanges, banks, financial services providers and investment houses by SOLACTIVE



# 2. INDEX SELECTION

On each Selection Day, the Index Administrator will revise the composition of the Index.

In a first step, the INDEX ADMINISTRATOR determines the INDEX UNIVERSE in accordance with Section 2.1. The INDEX UNIVERSE comprises all those financial instruments which fulfill the INDEX UNIVERSE REQUIREMENTS (as specified in Section 2.1) and will constitute a starting pool from which the components of the INDEX will be selected. Based on this INDEX UNIVERSE, the new composition of the INDEX will be determined by applying the rules outlined in Section 2.2.

Each new INDEX COMPONENT will be assigned a weight as described in Section 2.3.

#### 2.1. INDEX UNIVERSE REQUIREMENTS

The INDEX UNIVERSE is comprised of all financial instruments which fulfill the below requirements.

(the "INDEX UNIVERSE REQUIREMENTS"):

The Universe is determined on a quarterly basis on the SELECTION DAY, it consists of companies that fulfill the SELECTION POOL conditions defined in Section 6.

The determination of the INDEX UNIVERSE is fully rule-based and the INDEX ADMINISTRATOR cannot make any discretionary decisions.

### 2.2. SELECTION OF THE INDEX COMPONENTS

Based on the INDEX UNIVERSE, the initial composition of the INDEX as well as any selection for an ordinary rebalance is determined on the Selection DAY in accordance with the following rules:

Step 1: The Low Carbon Universe

The composition of "The Low Carbon Universe" is determined by identifying all entities in "The Eligible Universe" that fulfil all of the following criteria:

- 1. The company is not among the world's largest 100 oil & gas reserve holders or the world's largest 100 coal reserve holders.
- 2. If the company belongs to the Electric Utilities Factset Industries , it does not have more than 50% of its installed capacity related to Fossil Fuels.
- 3. The company measures and reports its greenhouse gas emissions



All data regarding the Oil & Gas and Coal Reserves is provided through ISS Ethix along with its research partner Fossil Free Indexes, who maintain and research the Carbon Underground 200TM, on which the reserve data is based. The information on Installed capacity related to Fossil Fuels is provided by ISS Ethix (the "Index Advisor").

#### Step 2: The Low Carbon Leaders Universe

The composition of "The Low Carbon Leaders Universe" is determined by identifying all entities in "The Low Carbon Universe" that fulfil the following criterion:

1. The company has a ratio of greenhouse gas emission (tCO2e) per \$m revenue below the median relative to companies in the Low Carbon Universe belonging to the same FactSet Economy.

The ratio of greenhouse gas emissions to revenue is provided for each company in the Low Carbon Universe by ISS Ethix (the "Index Advisor").

#### Step 3: Final Index

The final selection of the Index as well as any ongoing adjustment is based on the following rules:

1.If the number of companies in the Low Carbon Leaders Universe is higher than 50, the Index Calculator will select the Index Components following an iterative process.

- a) The Index Calculator will rank the companies in the Universe by Historical Volatility (the "Historical Volatility Ranking"):
- b) The company with the lowest historical volatility is assigned rank number 1, the company with the second-lowest historical volatility is assigned rank number 2, etc. For the avoidance of doubt, rank number 1 is higher than rank number 2.
- c) The next step will be to select the new composition after the rebalancing, according to their Historical Volatility in decreasing order. After each selection, the Index Calculator will count the number of companies belonging to each FactSet Economy. If the number of selected companies from any specific FactSet Economy reaches 12, no further company from that specific FactSet Economy may be added to the selected companies. The iterative process will end when the number of selected companies reaches 50. The selected companies will be the Index Composition after the rebalancing.
- d) Should the iterative process result in a number of selected companies lower than 50 after the lowest-ranked company is considered, there will be an additional process in order to reach 50 Index Components. The Index Calculator will sequentially add the companies from the Low Carbon Leaders Universe which were not already selected as Index Components in decreasing order of their Historical Volatility Ranking, regardless of their FactSet Economy. The additional process will end when the number of selected companies reaches 50. The selected companies will be the new Index Components after the rebalancing.
- 2. If there are less than 50 but more or equal to 30 after the last step those companies will constitute the index. The index components will be equal-weighted.



3. In case there are less than 30 companies in the Low Carbon Leaders Universe, the composition remains unchanged and will just be reweighted (equally) according to 2.3 of this document.

Solactive AG shall publish any changes made to the Index composition with sufficient notice before the Adjustment Day

#### 2.3. WEIGHTING OF THE INDEX COMPONENTS

On each REBALANCE DAY the Underlying INDEX COMPONENTS are weighted equally. The single steps are described in detail in section 2.1 and section 2.2

### 3. REBALANCE

#### 3.1. ORDINARY REBALANCE

In order to reflect the new selection of the INDEX COMPONENTS determined on the SELECTION DAY (in accordance with Section 2.1 and 2.2) the INDEX is adjusted on each REBALANCE DAY after CLOSE OF BUSINESS.

This is carried out by implementing the weights as determined on the SELECTION DAY

The INDEX is rebalanced over the REBALANCE PERIOD to downsize rebalance transactions in accordance with the Equity Index Methodology, which is incorporated by reference and available on the Solactive website: <a href="https://www.solactive.com/documents/equity-index-methodology/">https://www.solactive.com/documents/equity-index-methodology/</a>.

The Index is rebalanced quarterly over a ten day period to ensure that rebalance transactions stay below the AVERAGE DAILY VALUE TRADED. Beginning on the TRADING DAY immediately following the REBALANCE DAY, and continuing over the next nine TRADING DAYS, defined as the REBALANCE PERIOD, the target weights of the constituents of the Index on the  $m^{th}$  day are set as follows:

*M* = Total number of INDEX BUSINESS DAYS in the REBALANCE PERIOD i.e. 10.

SOLACTIVE will publish any changes made to the INDEX COMPONENTS with sufficient notice before the REBALANCE DAY on the SOLACTIVE website under the section "Announcement", which is available at <a href="https://www.solactive.com/news/announcements/">https://www.solactive.com/news/announcements/</a>

#### 3.2. EXTRAORDINARY REBALANCE

If an INDEX COMPONENT is removed between two REBALANCE DAYS due to an Extraordinary Event, the weight of the respective company will be split amongst the remaining companies. The INDEX is adjusted on the same day. This is announced by Solactive AG after the close of business on the day on which the new composition of the Index was determined by the OVERSIGHT COMMITTEE.



# 4. CALCULATION OF THE INDEX

#### 4.1. INDEX FORMULA

The INDEX is calculated as a net total return Index.

The calculation is performed according to the Equity Index Methodology, which is available on the Solactive website: <a href="https://www.solactive.com/documents/equity-index-methodology/">https://www.solactive.com/documents/equity-index-methodology/</a>. The standard index formula stipulates that the level of the INDEX changes based on the change of the prices of its INDEX COMPONENTS taking into account their weight in the INDEX and any currency conversion in case the price of an INDEX COMPONENT is quoted in a currency other than the INDEX CURRENCY

Any dividends or other distributions are reinvested back into the INDEX COMPONENT paying the dividend or other distribution at the opening of the effective date (the so called ex-date) of the payment of such dividend or other distribution.

A more detailed description of the mechanics of the index calculation formula can be found in the Equity Index Methodology under Section 1.2.

#### 4.2. ACCURACY

The level of the INDEX will be rounded to 2 decimal places.

#### 4.3. ADJUSTMENTS

Under certain circumstances, an adjustment of the INDEX may be necessary between two regular REBALANCE DAYS. Such adjustment has to be made if a corporate action (as specified in Section 4.4 below) in relation of an INDEX COMPONENT occurs. Such adjustment may have to be done in relation to an INDEX COMPONENT and/or may also affect the number of INDEX COMPONENTS and/or the weighting of certain INDEX COMPONENTS and will be made in compliance with the Solactive Equity Index Methodology, which is incorporated by reference and available on the SOLACTIVE website: <a href="https://www.solactive.com/documents/equity-index-methodology/">https://www.solactive.com/documents/equity-index-methodology/</a>.

SOLACTIVE will announce the INDEX adjustment giving a notice period of at least two TRADING DAYS (with respect to the affected INDEX COMPONENT) on the SOLACTIVE website under the Section "Announcements", which is available at <a href="https://www.solactive.com/news/announcements/">https://www.solactive.com/news/announcements/</a>. The INDEX adjustments will be implemented on the effective day specified in the respective notice.



#### 4.4. CORPORATE ACTIONS

As part of the INDEX maintenance Solactive will consider various events — also referred to as corporate actions — which result in an adjustment to the INDEX between two regular REBALANCE DAYS. Such events have a material impact on the price, weighting or overall integrity of INDEX COMPONENTS. Therefore, they need to be accounted for in the calculation of the INDEX. Corporate actions will be implemented from the cum-day to the ex-day of the corporate action, so that the adjustment to the INDEX coincides with the occurrence of the price effect of the respective corporate action.

Adjustments to the INDEX to account for corporate actions will be made in compliance with the Equity Index Methodology, which is available on the Solactive website: <a href="https://www.solactive.com/documents/equity-index-methodology/">https://www.solactive.com/documents/equity-index-methodology/</a>. This document contains for each corporate action a brief definition and specifies the relevant adjustment to the INDEX variables.

While Solactive aims at creating and maintaining its methodology for treatment of corporate actions as generic and transparent as possible and in line with regulatory requirements, it retains the right in accordance with the Equity Index Methodology to deviate from these standard procedures in case of any unusual or complex corporate action or if such a deviation is made to preserve the comparability and representativeness of the INDEX over time.

SOLACTIVE considers following, but not conclusive, list of corporate actions as relevant for INDEX maintenance:

- Cash Distributions (e.g. payment of a dividend)
- > Stock distributions (e.g. payment of a dividend in form of additional shares)
- > Stock distributions of another company (e.g. payment of a dividend in form of additional shares of another company (e.g. of a subsidiary))
- > Share splits (company's present shares are divided and therefore multiplied by a given factor)
- Reverse splits (company's present shares are effectively merged)
- Capital increases (such as issuing additional shares)
- > Share repurchases (a company offer its shareholders the option to sell their shares to a fixed price)
- > Spin-offs (the company splits its business activities into two or more entities and distributes new equity shares in the created entities to the shareholders of the former entity)
- Mergers & Acquisitions (transaction in which the ownership of a company (or other business organizations) are transferred or consolidated with other entities, e.g. fusion of two or more separate companies into one entity)
- Delistings (company's shares are no longer publicly traded at a stock exchange)
- Nationalization of a company (effective control of a legal entity is taken over by a state)
- > Insolvency



#### 4.5. RECALCULATION

SOLACTIVE makes the greatest possible efforts to accurately calculate and maintain its indices. However, errors in the determination process may occur from time to time for variety reasons (internal or external) and therefore, cannot be completely ruled out. Solactive endeavors to correct all errors that have been identified within a reasonable period of time. The understanding of "a reasonable period of time" as well as the general measures to be taken are generally depending on the underlying and is specified in the Solactive Correction Policy, which is incorporated by reference and available on the Solactive website: https://www.solactive.com/documents/correction-policy/.

#### 4.6. MARKET DISRUPTION

In periods of market stress Solactive calculates its indices following predefined and exhaustive arrangements as described in the Solactive Disruption Policy, which is incorporated by reference and available on the Solactive website: <a href="https://www.solactive.com/documents/disruption-policy/">https://www.solactive.com/documents/disruption-policy/</a>. Such market stress can arise due to a variety of reasons, but generally results in inaccurate or delayed prices for one or more INDEX COMPONENTS. The determination of the INDEX may be limited or impaired at times of illiquid or fragmented markets and market stress.



# 5. MISCELLANEOUS

#### 5.1. DISCRETION

Any discretion which may need to be exercised in relation to the determination of the INDEX (for example the determination of the INDEX UNIVERSE (if applicable), the selection of the INDEX COMPONENTS (if applicable) or any other relevant decisions in relation to the INDEX) shall be made in accordance with strict rules regarding the exercise of discretion or expert judgement.

#### 5.2. METHODOLOGY REVIEW

The methodology of the INDEX is subject to regular review, at least annually. In case a need of a change of the methodology has been identified within such review (e.g. if the underlying market or economic reality has changed since the launch of the INDEX, i.e. if the present methodology is based on obsolete assumptions and factors and no longer reflects the reality as accurately, reliably and appropriately as before), such change will be made in accordance with the Solactive Methodology Policy\_which is incorporated by reference and available on the SOLACTIVE website: <a href="https://www.solactive.com/documents/methodology-policy/">https://www.solactive.com/documents/methodology-policy/</a>.

Such change in the methodology will be announced on the SOLACTIVE website under the Section "Announcement", which is available at <a href="https://www.solactive.com/news/announcements/">https://www.solactive.com/news/announcements/</a>. The date of the last amendment of this INDEX is contained in this GUIDELINE.

#### 5.3. CHANGES IN CALCULATION METHOD

The INDEX ADMINISTRATOR shall apply the method described above for the composition and calculation of the INDEX. However, it cannot be excluded that the market environment, supervisory, legal and financial or tax reasons may require changes to be made to this method. The INDEX ADMINISTRATOR may also make changes to the terms and conditions of the INDEX and the method applied to calculate the INDEX that it deems to be necessary and desirable in order to prevent obvious or demonstrable error or to remedy, correct or supplement incorrect terms and conditions. The INDEX ADMINISTRATOR is not obliged to provide information on any such modifications or changes. Despite the modifications and changes, the INDEX ADMINISTRATOR will take the appropriate steps to ensure a calculation method is applied that is consistent with the method described above.



#### 5.4. TERMINATION

Solactive makes the greatest possible efforts to ensure the resilience and continued integrity of its indices over time. Where necessary, Solactive follows a clearly defined and transparent procedure to adapt Index methodologies to changing underlying markets (see Section 5.2 "Methodology Review") in order to maintain continued reliability and comparability of the indices. Nevertheless, if no other options are available the orderly cessation of the INDEX may be indicated. This is usually the case when the underlying market or economic reality, which an index is set to measure or to reflect, changes substantially and in a way not foreseeable at the time of inception of the index, the index rules, and particularly the selection criteria, can no longer be applied coherently or the index is no longer used as the underlying value for financial instruments, investment funds and financial contracts.

Solactive has established and maintains clear guidelines on how to identify situations in which the cessation of an index is unavoidable, how stakeholders are to be informed and consulted and the procedures to be followed for a termination or the transition to an alternative index. Details are specified in the Solactive Termination Policy, which is incorporated by reference and available on the Solactive website: <a href="https://www.solactive.com/documents/termination-policy/">https://www.solactive.com/documents/termination-policy/</a>.

#### 5.5. OVERSIGHT

An oversight committee composed of staff from Solactive and its subsidiaries and Forum Ethibel (the "Oversight Committee") is responsible for decisions regarding any amendments to the rules of the INDEX. Any such amendment, which may result in an amendment of the Guideline, must be submitted to the Oversight Committee for prior approval and will be made in compliance with the Methodology Policy, which is available on the Solactive website: <a href="https://www.solactive.com/documents/methodology-policy/">https://www.solactive.com/documents/methodology-policy/</a>.



# 6. DEFINITIONS

"AVERAGE DAILY VALUE TRADED" means, in respect of an INDEX COMPONENT, the sum of DAILY VALUE TRADED over the specified period divided by the number of TRADING DAYS that fall in the specified period.

"BENCHMARK REGULATION" shall have the meaning as defined in Section "Introduction".

"BMR" shall have the meaning as defined in Section "Introduction".

"CALCULATION DAY" is every weekday from Monday to Friday

"CLOSE OF BUSINESS" is the calculation time of the closing level of the INDEX as outlined in Section 1.4.

The "CLOSING PRICE" in respect of an INDEX COMPONENT and a TRADING DAY is a security's final regular-hours TRADING PRICE published by the EXCHANGE and determined in accordance with the EXCHANGE regulations. If the EXCHANGE has no or has not published a CLOSING PRICE in accordance with the EXCHANGE rules for an INDEX COMPONENT, the last TRADING PRICE will be used.

"DAILY VALUE TRADED" means, in respect of an INDEX COMPONENT and a TRADING DAY, the product of (i) the CLOSING PRICE of such INDEX COMPONENT and (ii) the volume traded (measured as a number of shares) of such INDEX COMPONENT on the EXCHANGE during such TRADING DAY.

**"DIVIDEND YIELD"** is the 12-months forward mean estimation as provided by by FactSet (or any reference source taking the place of FactSet and providing comparable data items, acceptable to and as determined by the Index Calculator) converted into the index currency divided by the current price of the stock converted into the index currency or similar data sources.

"ELIGIBLE REBALANCE DAY" is each day that is a TRADING DAY.

"ESG Research Provider" is Vigeo and Forum Ethibel.

**"EXCHANGE"** is with respect to the INDEX and every INDEX COMPONENT, the respective exchange where the INDEX COMPONENT has its primary listing as determined in accordance with the rules in Section 2. OVERSIGHT COMMITTEE may decide to declare a different stock exchange the "Exchange" for trading reasons, even if the company is only listed there via a STOCK SUBSTITUTE.

**"FACTSET SECTOR"** means the sector classification as provided by FactSet Research Systems (Mnemonic=FG\_FACTSET\_ECONOMY).

The "FREE FLOAT" is with regard to each of the securities fulfilling the INDEX COMPONENT REQUIREMENTS on a SELECTION DAY the share class-specific fraction of the total number of shares of such share class issued that are available for trading by market participants and not locked-in by long term holders, as sourced from data vendors.

The "FREE FLOAT MARKET CAPITALIZATION" is with regard to each of the securities fulfilling the INDEX COMPONENT REQUIREMENTS on a SELECTION DAY the share class-specific free float market capitalization. It is calculated as the multiplication of the shares outstanding in FREE FLOAT (as sourced from data vendors) with the CLOSING PRICE of the share class as of the respective SELECTION DAY.



- "GEOGRAPHICAL REGION" is one of the following three classifications: Europe, Asia, and America.
- "GUIDELINE" shall have the meaning as defined in Section "Introduction".
- "HISTORIC VOLATILITY" is the 6 months historical volatility in local currency.
- "INDEX" shall have the meaning as defined in Section "Introduction".
- "INDEX ADMINISTRATOR" shall have the meaning as defined in Section "Introduction".
- "INDEX BUSINESS DAY" is a day on which all securities which are components of the UNDERLYING INDEX are tradable, i.e. all relevant exchanges are open for trading.
- "INDEX COMPONENT" is each security reflected in the INDEX.
- "INDEX COMPONENT REQUIREMENTS" shall have the meaning as defined in Section 2.2.
- "INDEX CURRENCY" is the currency specified in the column "Currency" in the table in Section 1.2.
- "INDEX UNIVERSE REQUIREMENTS" shall have the meaning as defined in Section 2.1.
- "INDEX UNIVERSE" is the sum of all financial instruments which fulfill the INDEX UNIVERSE REQUIREMENTS.
- "LIVE DATE" shall have the meaning as defined in Section 1.3.
- "Market Capitalization" is with regard to each of the shares in the Selection Pool on a Selection Day or Rebalance Day the value published by Reuters (or a successor) as the Market Capitalization for this day.
- "Oversight Committee" shall have the meaning as defined in Section 5.5.
- "REBALANCE DAY" is close of the first Wednesday in February, May, August and November. If this is not a Trading Day, the Rebalance Day is moved to next Trading Day.
- "REBALANCE PERIOD" is the period starting from (and including) the REBALANCE DAY until and (including) the immediately following 9 Trading Days. The entire REBALANCE PERIOD lasts for 10 Trading Days.
- **"Sector**" is one of the following ten classifications: Consumer Goods, Industrials, Basic Materials, Oil & Gas, Health Care, Utilities, Consumer Services, Financials, Technology, and Telecommunications
- "SELECTION DAY" is the CALCULATION DAY which is ten CALCULATION DAYS prior to the scheduled Rebalance Day
- "SELECTION POOL" consists of companies, that fulfills all of the following requirements:
- (a) Component of the Solactive US Large & Mid Cap Index (SOLUSMCP), taking into account any future component changes known as of the SELECTION DAY.
- (b) AVERAGE DAILY VALUE TRADED over the 6 months until and including the SELECTION DAY of at least 10 million USD measured using composite AVERAGE DAILY VALUE TRADED over all exchanges in the US. Companies that do not have a 6 months history (Spin Offs, IPOs) need to fulfil the requirement for the period of time they traded on an exchange. However, every potential inclusion as of the IPO Adjustment Day or ordinary REBALANCE DAY needs to have at least a history of 10 Trading Days as of the IPO Review Day and / or the ordinary SELECTION DAY.



- (c) The company must be incorporated in the US as of the SELECTION DAY.
- (d) The companies must not belong to the following FactSet Industries
- Oil Refining/Marketing
- Oilfield Services/Equipment
- Oil & Gas Production
- Integrated Oil
- Oil & Gas Pipelines
- Coal
- Gas Distributors

"STOCK SUBSTITUTE" includes in particular American Depository Receipts (ADR) and Global Depository Receipts (GDR).

"**TARGET WEIGHT**" is defined as the weight that will be implemented for an INDEX COMPONENT at the end of the REBALANCE PERIOD.

"TRADING DAY" is with respect to an INDEX COMPONENT included in the INDEX at the REBALANCE DAY and every INDEX COMPONENT included in the INDEX at the CALCULATION DAY immediately following the REBALANCE DAY (for clarification: this provision is intended to capture the TRADING DAYS for the securities to be included in the INDEX as new INDEX COMPONENTS with close of trading on the relevant EXCHANGE on the REBALANCE DAY) a day on which the relevant EXCHANGE is open for trading (or a day that would have been such a day if a market disruption had not occurred), excluding days on which trading may be ceased prior to the scheduled EXCHANGE closing time and days on which the EXCHANGE is open for a scheduled shortened period. The INDEX ADMINISTRATOR is ultimately responsible as to whether a certain day is a TRADING DAY.

The **"Trading Price"** in respect of an INDEX COMPONENT and a Trading Day is the most recent published price at which the INDEX COMPONENT was traded on the respective EXCHANGE.

"WM / REFINITIV RATE" shall have the meaning as defined in Section 1.4.
