### INTRODUCTION

This document (the "GUIDELINE") is to be used as a guideline with regard to the composition, calculation and maintenance of the RENEWABLES & CLEAN ENERGY INDEX (the "INDEX"). Any amendments to the rules made to the GUIDELINE are approved by the OVERSIGHT COMMITTEE specified in Section 5.5. The INDEX is property of Goldman Sachs International which has contracted Solactive AG ("SOLACTIVE") to calculate, administer and publish the INDEX. SOLACTIVE will assume the role as administrator (the "INDEX ADMINISTRATOR") under the Regulation (EU) 2016/1011 (the "BENCHMARK REGULATION" or "BMR"). The name "Solactive" is trademarked.

The text uses defined terms which are formatted with "SMALL CAPS". Such Terms shall have the meaning assigned to them as specified in Section 6 (Definitions).

The Guideline and the policies and methodology documents referenced herein contain the underlying principles and rules regarding the structure and operation of the INDEX. Solactive does not offer any explicit or tacit guarantee or assurance, neither pertaining to the results from the use of the INDEX nor the level of the INDEX at any certain point in time nor in any other respect. Solactive strives to the best of its ability to ensure the correctness of the calculation. The INDEX is published on the website of the INDEX ADMINISTRATOR (<a href="www.solactive.com">www.solactive.com</a>) and is, in addition, available via the price marketing services of Boerse Stuttgart GmbH and may be distributed to all of its affiliated vendors. Each vendor decides on an individual basis as to whether it will distribute or display the INDEX via its information systems.

#### 1.3. INITIAL LEVEL OF THE INDEX

The initial level of the INDEX on the 03/05/2017, the START DATE, is 1000. Historical values from the 25/06/2021, the LIVE DATE, will be recorded in accordance with Article 8 of the BMR. Levels of the INDEX published for a period prior to the LIVE DATE have been back-tested.

#### 1.4. PRICES AND CALCULATION FREQUENCY

The level of the INDEX is calculated on each CALCULATION DAY from 01:00 a.m. to 10:50 p.m. CET based on the TRADING PRICES on the EXCHANGES on which the INDEX COMPONENTS are listed. TRADING PRICES of INDEX COMPONENTS not listed in the INDEX CURRENCY are converted using the current Intercontinental Exchange (ICE) spot foreign exchange rate. Should there be no current Trading Price for an INDEX COMPONENT, the later of: (i) the most recent Closing Price; or (ii) the last available Trading Price for the preceding Trading Day is used in the calculation.

In addition to the intraday calculation a closing level of the INDEX for each CALCULATION DAY is also calculated. This closing level is based on the CLOSING PRICES for the INDEX COMPONENTS on the respective EXCHANGES on which the INDEX COMPONENTS are listed. The CLOSING PRICES of INDEX COMPONENTS not listed in the INDEX CURRENCY are converted using the 04:00 p.m. London time WM Fixing quoted by Reuters. If there is no 04:00 p.m. London time WM Fixing for the relevant CALCULATION DAY, the last available 04:00 p.m. London time WM Fixing will be used for the closing level calculation.

#### 1.5. LICENSING

Licenses to use the INDEX as the underlying value for financial instruments, investment funds and financial contracts may be issued to stock exchanges, banks, financial services providers and investment houses by Goldman Sachs International.



# 2. INDEX SELECTION

On each Selection Day, the Index Administrator will revise the composition of the Index.

In a first step, the INDEX ADMINISTRATOR determines the INDEX UNIVERSE in accordance with Section 2.1. The INDEX UNIVERSE comprises all those financial instruments which fulfill the INDEX UNIVERSE REQUIREMENTS (as specified in Section 2.1) and will constitute a starting pool from which the components of the INDEX will be selected. Based on this INDEX UNIVERSE, the new composition of the INDEX will be determined by applying the rules outlined in Section 2.2.

Each new INDEX COMPONENT will be assigned a weight as described in Section 2.3.

#### 2.1. INDEX UNIVERSE REQUIREMENTS

The INDEX UNIVERSE is comprised of all financial instruments which fulfill the below requirements (the "INDEX UNIVERSE REQUIREMENTS"):

- Part/ Component of the **GBS INDEX UNIVERSE** of the *Solactive GBS Global Markets All Cap USD Index PR (ISIN: DE000SLA78E2)*, on a SELECTION DAY
- Listed on an exchange in the United States
- Have a minimum 60-day median Daily Value Traded of USD 10 million at Selection Day

The determination of the INDEX UNIVERSE is fully rule-based and the INDEX ADMINISTRATOR cannot make any discretionary decisions.

### 2.2. SELECTION OF THE INDEX COMPONENTS

Based on the INDEX UNIVERSE, the initial composition of the INDEX as well as any selection for an ordinary rebalance is determined on the SELECTION DAY in accordance with the following rules (the "INDEX COMPONENT REQUIREMENTS"):

#### ESG Screen:

Securities that have a product involvement of at least 25%, as determined by the DATA PROVIDER, in any of the below categories, are selected as INDEX COMPONENTS:

- Green Transportation Vehicles
- o Green Transportation Tech
- o Green Transportation Services



- o Green Transportation Infrastructure
- o Renewable Energy Generation
- o Renewable Energy Supporting Products
- o Green Building Development
- Green Building Management
- Green Building Tech and Materials
- Pollution Prevention and Reduction
- Energy Efficiency Distribution and Management
- Energy Efficiency Materials
- Energy Efficiency Industrial Systems
- Energy Efficiency Consumer Products
- Resource Efficiency Technologies and Services

#### ARTIS® Screen:

The second part of the selection is done based on screening of publicly available information such as financial news, business profiles, and company publications using ARTIS®, SOLACTIVE'S proprietary natural language processing algorithm.

Only companies from the INDEX UNIVERSE classified as Consumer Services, Consumer Durables, Industrials, Basic Materials or Technology as defined by the first level of the FactSet Industries and Economic Sectors Classification are eligible for the ARTIS® Screen.

ARTIS® utilizes an algorithm to attempt to identify companies that are relevant to the electric vehicles and key suppliers and hydrogen themes based on whether and the extent to which a company uses one or more of the identified keywords in its publications. By incorporating a concept of probability of relevance, the algorithm attempts to estimate how likely it is that a document is relevant to the theme based on calculations that take into account the frequency with which a keyword (or keywords) is used in the document, and the rareness of the keyword(s) (measured by the frequency with which the keyword(s) appears across all documents in the Search Corpus). The algorithm generally (i) gives more importance to documents which contain a higher number of search matches, (ii) gives less importance to documents that contain keywords that are commonly used across the search corpus (based on the idea that common words are less important to the calculation of relevance) and (iii) gives less importance to the repetition of a single keyword throughout a document as compared to matches of several different keywords in a document. Balancing these competing objectives through the algorithm means that a high number of search hits alone does not necessarily translate into a high score or a high level of relevance for a document. The



sources include, but are not limited to, company filings, financial news and business descriptions. An extract of the keywords for each theme is listed in the Appendix.

Each company identified by ARTIS® receives a score that reflects its exposure to the index strategy. For each of the themes, the z-score of the ARTIS® score is calculated based on the mean and standard deviation of the ARTIS® scores of the eligible companies in the INDEX UNIVERSE. Companies with a z-score larger than 1 are eligible for the final INDEX.

This set of companies is then reviewed to ensure relevance to the theme based on business operations. Companies that do not have relevant business exposure to the themes are removed from the selection process at this stage.

The INDEX UNIVERSE listings of the remaining companies that are not already selected by the ESG Screen are selected as INDEX COMPONENTS.

In case there are less than 35 securities eligible after the ESG and ARTIS® screen, the product involvement threshold of 25% in the ESG Screen is iteratively reduced until at least 35 securities are selected.

Securities listed on the RESTRICTED TRADING LIST are not eligible INDEX COMPONENTS. The exceptions to this are securities that are listed on the RESTRICTED TRADING LIST and are already in the INDEX due to a past selection. Those securities are always selected as INDEX COMPONENTS.

The INDEX ADMINISTRATOR has outsourced part of the selection of the INDEX COMPONENTS, precisely the determination of the Restricted Trading List, to the Restricted Trading List Provider.

#### 2.3. WEIGHTING OF THE INDEX COMPONENTS

On each Selection Day each Index Component is assigned a weight based on a liquidity weighted portfolio subject to the following optimization constraints:

- Individual weights are capped at 3%
- The maximum holding liquidity is 30%
- The maximum trading liquidity is 10%
- Maximum two-way turnover is 100%

Liquidity is defined as 60-day median DAILY VALUE TRADED and trading liquidity constraint is calculated assuming a notional of USD 500 million.

In the event that no feasible solution can be found to the above optimization problem, the maximum holding liquidity and maximum trading liquidity constraints are iteratively relaxed until a solution is found. The holding liquidity constraint is thereby relaxed at a relatively higher rate.

Securities already in the INDEX that are not eligible at SELECTION DAY will be excluded from the INDEX subject to the above constraints. This means that if the constraints do not allow immediate exclusion, securities



will be phased out over multiple Selection Days ("grandfathering") where the optimization aims at maximum weight reduction.

Securities with weights smaller than 0.01% are excluded from the INDEX after optimization with the weights being redistributed to the other INDEX COMPONENTS pro rata. In case there are less than 35 securities after that step, the threshold of 0.01% is reduced in a way that at least 35 securities are in the final INDEX.

Securities selected as INDEX COMPONENTS because they are already in the Index and listed on the RESTRICTED TRADING LIST are treated as fixed components. They are not subject to the above optimization constraints. Their weights do not change due to the selection and weighting process of the remaining INDEX COMPONENTS.



# 3. REBALANCE

#### 3.1. ORDINARY REBALANCE

In order to reflect the new selection of the INDEX COMPONENTS determined on the SELECTION DAY (in accordance with Section 2.1 and 2.2) the INDEX is adjusted on the REBALANCE DAY after CLOSE OF BUSINESS.

This is carried out by implementing the shares as determined on the FIXING DAY based on the weights calculated on the Selection Day.

On each REBALANCE DAY there is a 0.03% rebalancing fee subtracted based on the total absolute change in the weights of each financial instrument entering or leaving the INDEX. The rebalancing fee will be applied in compliance with the Solactive Equity Index Methodology, which is incorporated by reference and available on the Solactive website: https://www.solactive.com/documents/equity-index-methodology/.

SOLACTIVE will publish any changes made to the INDEX COMPONENTS with sufficient notice before the REBALANCE DAY on the SOLACTIVE website under the section "Announcement", which is available at https://www.solactive.com/news/announcements/

#### 3.2. FXTRAORDINARY RFBALANCE

The INDEX is not rebalanced extraordinarily.



# 4. CALCULATION OF THE INDEX

#### 4.1. INDEX FORMULA

The INDEX is calculated as a price return, net total return, gross total return Index.

The calculation is performed according to the Equity Index Methodology, which is available on the Solactive website: <a href="https://www.solactive.com/documents/equity-index-methodology/">https://www.solactive.com/documents/equity-index-methodology/</a>. The divisor index formula stipulates that the level of the INDEX changes based on the change of the prices of its INDEX COMPONENTS taking into account their weight in the INDEX and any currency conversion in case the price of an INDEX COMPONENT is quoted in a currency other than the INDEX CURRENCY.

Any dividends or other distributions are reinvested across the entire basket of INDEX COMPONENTS by means of a divisor at the opening of the effective date (the so-called ex-date) of the payment of such dividend or other distribution.

A more detailed description of the mechanics of the index calculation formula can be found in the Equity Index Methodology under Section 1.2.

In order to calculate any net amount to be reinvested, the index takes a universal withholding tax rate fixed at 10% for any distribution or reinvestment into the index.

#### 4.2. ACCURACY

The level of the INDEX will be rounded to two decimal places. Divisors will be rounded to six decimal places. TRADING PRICES and foreign exchange rates will be rounded to six decimal places.

#### 4.3. ADJUSTMENTS

Under certain circumstances, an adjustment of the INDEX may be necessary between two regular REBALANCE DAYS. Such adjustment has to be made if a corporate action (as specified in Section 4.4 below) in relation of an INDEX COMPONENT occurs. Such adjustment may have to be done in relation to an INDEX COMPONENT and/or may also affect the number of INDEX COMPONENTS and/or the weighting of certain INDEX COMPONENTS and will be made in compliance with the Solactive Equity Index Methodology, which is incorporated by reference and available on the Solactive website: <a href="https://www.solactive.com/documents/equity-index-methodology/">https://www.solactive.com/documents/equity-index-methodology/</a>.

SOLACTIVE will announce the INDEX adjustment giving a notice period of at least two TRADING DAYS (with respect to the affected INDEX COMPONENT) on the SOLACTIVE website under the Section "Announcements",



which is available at <a href="https://www.solactive.com/news/announcements/">https://www.solactive.com/news/announcements/</a>. The INDEX adjustments will be implemented on the effective day specified in the respective notice.

#### 4.4. CORPORATE ACTIONS

As part of the INDEX maintenance Solactive will consider various events — also referred to as corporate actions — which result in an adjustment to the INDEX between two regular REBALANCE DAYS. Such events have a material impact on the price, weighting or overall integrity of INDEX COMPONENTS. Therefore, they need to be accounted for in the calculation of the INDEX. Corporate actions will be implemented from the cum-day to the ex-day of the corporate action, so that the adjustment to the INDEX coincides with the occurrence of the price effect of the respective corporate action.

Adjustments to the INDEX to account for corporate actions will be made in compliance with the Equity Index Methodology, which is available on the SOLACTIVE website: <a href="https://www.solactive.com/documents/equity-index-methodology/">https://www.solactive.com/documents/equity-index-methodology/</a>. This document contains for each corporate action a brief definition and specifies the relevant adjustment to the INDEX variables.

While Solactive aims at creating and maintaining its methodology for treatment of corporate actions as generic and transparent as possible and in line with regulatory requirements, it retains the right in accordance with the Equity Index Methodology to deviate from these standard procedures in case of any unusual or complex corporate action or if such a deviation is made to preserve the comparability and representativeness of the INDEX over time.

SOLACTIVE considers following, but not conclusive, list of corporate actions as relevant for INDEX maintenance:

- Cash Distributions (e.g. payment of a dividend)
- > Stock distributions (e.g. payment of a dividend in form of additional shares)
- > Stock distributions of another company (e.g. payment of a dividend in form of additional shares of another company (e.g. of a subsidiary))
- > Share splits (company's present shares are divided and therefore multiplied by a given factor)
- Reverse splits (company's present shares are effectively merged)
- Capital increases (such as issuing additional shares)
- > Share repurchases (a company offer its shareholders the option to sell their shares to a fixed price)
- > Spin-offs (the company splits its business activities into two or more entities and distributes new equity shares in the created entities to the shareholders of the former entity)
- Mergers & Acquisitions (transaction in which the ownership of a company (or other business organizations) are transferred or consolidated with other entities, e.g. fusion of two or more separate companies into one entity)



- Delistings (company's shares are no longer publicly traded at a stock exchange)
- Nationalization of a company (effective control of a legal entity is taken over by a state)
- > Insolvency

#### 4.5. RECALCULATION

SOLACTIVE makes the greatest possible efforts to accurately calculate and maintain its indices. However, errors in the determination process may occur from time to time for variety reasons (internal or external) and therefore, cannot be completely ruled out. SOLACTIVE endeavors to correct all errors that have been identified within a reasonable period of time. The understanding of "a reasonable period of time" as well as the general measures to be taken are generally depending on the underlying and is specified in the Solactive Correction Policy, which is incorporated by reference and available on the SOLACTIVE website: <a href="https://www.solactive.com/documents/correction-policy/">https://www.solactive.com/documents/correction-policy/</a>.

#### 4.6. MARKET DISRUPTION

In periods of market stress Solactive calculates its indices following predefined and exhaustive arrangements as described in the Solactive Disruption Policy, which is incorporated by reference and available on the Solactive website: <a href="https://www.solactive.com/documents/disruption-policy/">https://www.solactive.com/documents/disruption-policy/</a>. Such market stress can arise due to a variety of reasons, but generally results in inaccurate or delayed prices for one or more INDEX COMPONENTS. The determination of the INDEX may be limited or impaired at times of illiquid or fragmented markets and market stress.



# 5. MISCELLANEOUS

#### 5.1. DISCRETION

Any discretion which may need to be exercised in relation to the determination of the INDEX (for example the determination of the INDEX UNIVERSE (if applicable), the selection of the INDEX COMPONENTS (if applicable) or any other relevant decisions in relation to the INDEX) shall be made in accordance with strict rules regarding the exercise of discretion or expert judgement.

#### 5.2. METHODOLOGY REVIEW

The methodology of the INDEX is subject to regular review, at least annually. In case a need of a change of the methodology has been identified within such review (e.g. if the underlying market or economic reality has changed since the launch of the INDEX, i.e. if the present methodology is based on obsolete assumptions and factors and no longer reflects the reality as accurately, reliably and appropriately as before), such change will be made in accordance with the Solactive Methodology Policy\_which is incorporated by reference and available on the SOLACTIVE website: <a href="https://www.solactive.com/documents/methodology-policy/">https://www.solactive.com/documents/methodology-policy/</a>.

Such change in the methodology will be announced on the SOLACTIVE website under the Section "Announcement", which is available at https://www.solactive.com/news/announcements/. The date of the last amendment of this INDEX is contained in this GUIDELINE.

#### 5.3. CHANGES IN CALCULATION METHOD

The INDEX ADMINISTRATOR shall apply the method described above for the composition and calculation of the INDEX. However, it cannot be excluded that the market environment, supervisory, legal and financial or tax reasons may require changes to be made to this method. The INDEX ADMINISTRATOR may also make changes to the terms and conditions of the INDEX and the method applied to calculate the INDEX that it deems to be necessary and desirable in order to prevent obvious or demonstrable error or to remedy, correct or supplement incorrect terms and conditions. The INDEX ADMINISTRATOR is not obliged to provide information on any such modifications or changes. Despite the modifications and changes, the INDEX ADMINISTRATOR will take the appropriate steps to ensure a calculation method is applied that is consistent with the method described above.



#### 5.4. TERMINATION

Solactive makes the greatest possible efforts to ensure the resilience and continued integrity of its indices over time. Where necessary, Solactive follows a clearly defined and transparent procedure to adapt Index methodologies to changing underlying markets (see Section 5.2 "Methodology Review") in order to maintain continued reliability and comparability of the indices. Nevertheless, if no other options are available the orderly cessation of the INDEX may be indicated. This is usually the case when the underlying market or economic reality, which an index is set to measure or to reflect, changes substantially and in a way not foreseeable at the time of inception of the index, the index rules, and particularly the selection criteria, can no longer be applied coherently or the index is no longer used as the underlying value for financial instruments, investment funds and financial contracts.

SOLACTIVE has established and maintains clear guidelines on how to identify situations in which the cessation of an index is unavoidable, how stakeholders are to be informed and consulted and the procedures to be followed for a termination or the transition to an alternative index. #### 5.5. OVERSIGHT

An oversight committee composed of staff from SOLACTIVE and its subsidiaries (the "**OVERSIGHT COMMITTEE**") is responsible for decisions regarding any amendments to the rules of the INDEX. Any such amendment, which may result in an amendment of the GUIDELINE, must be submitted to the OVERSIGHT COMMITTEE for prior approval and will be made in compliance with the Methodology Policy, which is available on the SOLACTIVE website: https://www.solactive.com/documents/methodology-policy/.



### 6. DEFINITIONS

"BENCHMARK REGULATION" shall have the meaning as defined in Section "Introduction".

"BMR" shall have the meaning as defined in Section "Introduction".

"Business Day" is a day on which the New York Stock Exchange (NYSE) is open for general business.

**"CALCULATION DAY"** is a day on which the New York Stock Exchange (NYSE) is not open for general business is not a CALCULATION DAY.

"CLOSE OF BUSINESS" is the calculation time of the closing level of the INDEX as outlined in Section 1.4.

The "CLOSING PRICE" in respect of an INDEX COMPONENT and a TRADING DAY is a security's final regular-hours TRADING PRICE published by the EXCHANGE and determined in accordance with the EXCHANGE regulations. If the EXCHANGE has no or has not published a CLOSING PRICE in accordance with the EXCHANGE rules for an INDEX COMPONENT, the last TRADING PRICE will be used.

"DAILY VALUE TRADED" means, in respect of an INDEX COMPONENT and a TRADING DAY, the product of (i) the CLOSING PRICE of such INDEX COMPONENT and (ii) the volume traded (measured as a number of shares) of such INDEX COMPONENT on the EXCHANGE during such TRADING DAY.

"DATA PROVIDER" is Sustainalytics. For more information, please visit: <a href="https://www.sustainalytics.com/">https://www.sustainalytics.com/</a>.

**"EXCHANGE"** is with respect to the INDEX and every INDEX COMPONENT, the respective exchange where the INDEX COMPONENT has its listing as determined in accordance with the rules in Section 2.

"FIXING DAY" is SELECTION DAY.

"GBS INDEX COMPONENT" is each security reflected in the GBS Index specified in Section 2.1.

"GUIDELINE" shall have the meaning as defined in Section "Introduction".

"INDEX" shall have the meaning as defined in Section "Introduction".

"INDEX ADMINISTRATOR" shall have the meaning as defined in Section "Introduction".

"INDEX COMPONENT" is each security reflected in the INDEX.

"INDEX COMPONENT REQUIREMENTS" shall have the meaning as defined in Section 2.2.

"INDEX CURRENCY" is the currency specified in the column "Currency" in the table in Section 1.2.

"INDEX UNIVERSE REQUIREMENTS" shall have the meaning as defined in Section 2.1.

"INDEX UNIVERSE" is the sum of all financial instruments which fulfill the INDEX UNIVERSE REQUIREMENTS.

"LIVE DATE" shall have the meaning as defined in Section 1.3.

"Oversight Committee" shall have the meaning as defined in Section 5.5.

"REBALANCE DAY" is five Business Days after the Selection Day. If that day is not a Business Day the Rebalance Day will be the immediately following Business Day.



"RESTRICTED TRADING LIST" is a list of securities that are not eligible for trading by Goldman Sachs Group, Inc. (or any of its affiliates) on the basis of legal, regulatory or policy reasons. Such list to be provided in accordance with an outsourcing arrangement concluded between SOLACTIVE and the RESTRICTED TRADING LIST PROVIDER in accordance with the requirements of the BMR (Article 10 BMR).

"RESTRICTED TRADING LIST PROVIDER" is Goldman Sachs International.

"SELECTION DAY" the last Wednesday of January, April, July and October.

"SOLACTIVE" shall have the meaning as defined in Section "Introduction".

"START DATE" shall have the meaning as defined in Section 1.3.

"TRADING DAY" is with respect to an INDEX COMPONENT included in the INDEX at the REBALANCE DAY and every INDEX COMPONENT included in the INDEX at the CALCULATION DAY immediately following the REBALANCE DAY (for clarification: this provision is intended to capture the TRADING DAYS for the securities to be included in the INDEX as new INDEX COMPONENTS with close of trading on the relevant EXCHANGE on the REBALANCE DAY) a day on which the relevant EXCHANGE is open for trading (or a day that would have been such a day if a market disruption had not occurred), excluding days on which trading may be ceased prior to the scheduled EXCHANGE closing time and days on which the EXCHANGE is open for a scheduled shortened period. The INDEX ADMINISTRATOR is ultimately responsible as to whether a certain day is a TRADING DAY.

The "TRADING PRICE" in respect of an INDEX COMPONENT and a TRADING DAY is the most recent published price at which the INDEX COMPONENT was traded on the respective EXCHANGE.
