INTRODUCTION

This document (the "Guideline") is to be used as a guideline with regard to the composition, calculation and maintenance Solactive Transat Enhanced Exposure EZ Social Screened Series (the "Indices"), comprised of the Solactive Transatlantic Enhanced Exposure EZ Social Screened 50 EUR Index (the Enhanced Exposure EZ Social Screened 50 Decrement 50 EUR Index (the Decrement Index). Any amendments to the rules made to the Guideline are approved by the Index Committee specified in Section 5.6. The Index is owned calculated, administered and published by Solactive AG ("Solactive") assuming the role as administrator (the "Index Administrator") under the Regulation (EU) 2016/1011 (the "Benchmark Regulation" or "BMR"). The name "Solactive" is trademarked.

The text uses defined terms which are formatted with "SMALL CAPS". Such Terms shall have the meaning assigned to them as specified in Section 6 (Definitions).

The Guideline and the policies and methodology documents referenced herein contain the underlying principles and rules regarding the structure and operation of the INDEX. Solactive does not offer any explicit or tacit guarantee or assurance, neither pertaining to the results from the use of the INDEX nor the level of the INDEX at any certain point in time nor in any other respect. The Indices are published on the website of the Index Administrator (www.solactive.com) and is, in addition, available via the price marketing services of Boerse Stuttgart GmbH and may be distributed to all of its affiliated vendors. Each vendor decides on an individual basis as to whether it will distribute or display the Index via its information systems.

1.3. INITIAL LEVEL OF THE INDEX

The initial level of the *Enhanced Exposure Index* on the 6th February 2019, the Index START DATE, is 1000. The initial level of the *Decrement Index* on the 6th February 2019, the Index START DATE, is 385.112377644073. Historical values from the 29th November 2024, the LIVE DATE, will be recorded in accordance with Article 8 of the BMR. Levels of the INDEX published for a period prior to the LIVE DATE have been back-tested.

1.4. PRICES AND CALCULATION FREQUENCY

The level of the Enhanced Exposure Index is calculated on each Calculation Day from 9:00am to 10:54 p.m. CET based on the Prices for the Index Components as calculated and published by Solactive. Prices of Index Components not listed in the Index Currency are converted using the current Intercontinental Exchange (ICE) spot foreign exchange rate.

The level of the *Decrement Index* is calculated on each Calculation Day from 9:00am to 10:56 p.m. CET based on the Prices for the Index Components as calculated and published by Solactive. Prices of Index Components not listed in the Index Currency are converted using the current Intercontinental Exchange (ICE) spot foreign exchange rate.

In addition to the intraday calculation a closing level of the INDICES for each CALCULATION DAY is also calculated. This closing level is based on the CLOSING PRICES for the INDEX COMPONENTS as calculated and published by Solactive. The CLOSING PRICES of INDEX COMPONENTS not listed in the INDEX CURRENCY are converted using the 04:00 p.m. London time rates provided by WM/ Refinitiv (the "WM/ Refinitiv Rate.

1.5. LICENSING

Licenses to use the INDEX as the underlying value for financial instruments, investment funds and financial contracts may be issued to stock exchanges, banks, financial services providers and investment houses by Solactive

3. CALCULATION OF THE INDEX

3.1. INDEX FORMULA FOR ENHANCED EXPOSURE

The Enhanced Exposure Index for any Calculation Day t, denoted $Index_t$, is determined in accordance with the following formula, where $Index_0 = 100$:

$$Enhanced_{t} = Enhanced_{t-1} * \left(1 + w_{1} * \left(\frac{CP_{1,t} * USDEUR_{t}}{CP_{1,t-1} * USDEUR_{t-1}} - 1\right) + w_{2} * \left(\frac{CP_{2,t}}{CP_{2,t-1}} - 1\right)\right)$$

With:

 $Enhanced_t$ = The level of the Enhanced Exposure Index as of Calculation Day t

 $Enhanced_{t-1}$ = The level of the <code>Enhanced Exposure Index</code> as of <code>Calculation Day t-1</code>

 w_i = The weight of INDEX COMPONENT i in the ENHANCED EXPOSURE INDEX as per Section 2.1



 $CP_{i,t}$ = The Closing Price of Index Component i in the *Enhanced Exposure Index* as of Calculation Day t

 $CP_{i,t-1}$ = The Closing Price of Index Component i in the *Enhanced Exposure Index* as of Calculation Day t-1

 USDEUR_t = The WMR USDEUR FX rate as of Calculation Day t

 USDEUR_{t-1} = The WMR USDEUR FX rate as of Calculation Day t-1

3.2. INDEX FORMULA FOR DECREMENT

The *Decrement Index* for any Calculation Day t, denoted $Index_t$, is determined in accordance with the following formula, where $Index_0 = 385.112377644073$:

$$Decrement_{t-1} * \frac{CP_{1,t}}{CP_{1,t-1}} - decrement * DCF_{t-1,t}$$

With:

 $Decrement_t$ = The level of the Decrement INDEX as of CALCULATION DAY t

 $Decrement_{t-1}$ = The level of the Decrement INDEX as of CALCULATION DAY t-1

 $CP_{1,t}$ = The Closing Price of Index Component 1 in the *Decrement Index* as of Calculation Day t

 $CP_{1,t-1}$ = The Closing Price of Index Component 1 in the *Decrement Index* as of Calculation Day t-1

decrement = The decrement of 50 points.

 $DCF_{t-1,t}$ = The number of calendar days between of Calculation Day t (excluded) and of Calculation Day t-1 (included), divided by 360.

Note that the level of 385.112377644073 as of the Start Date implies a level as of 800 as of 29^{th}

October 2024:

$$Decrement_{t fix} = 800$$

Where:

 t_fix : The fixing date of 29th October 2024.



3.3. ACCURACY

The level of the INDICES will be rounded to 2 decimal places for publication.

3.4. ADJUSTMENTS

Under certain circumstances, an adjustment of the INDICES may be necessary between two regular REBALANCE DAYS. Such adjustment has to be made if a corporate action (as specified in Section 4.4 below) in relation of an INDEX COMPONENT occurs. Such adjustment may have to be done in relation to an INDEX COMPONENT and/or may also affect the number of INDEX COMPONENTS and/or the weighting of certain INDEX COMPONENTS and will be made in compliance with the SOLACTIVE Equity Index Methodology, which is incorporated by reference and available on the SOLACTIVE website: https://www.solactive.com/documents/equity-index-methodology/.

SOLACTIVE will announce the INDEX adjustment giving a notice period of at least two TRADING DAYS (with respect to the affected INDEX COMPONENT) on the SOLACTIVE website under the Section "Announcements", which is available at https://www.solactive.com/news/announcements/. The INDEX adjustments will be implemented on the effective day specified in the respective notice.

3.5. RECALCULATION

Solactive makes the greatest possible efforts to accurately calculate and maintain its indices. However, errors in the determination process may occur from time to time for variety reasons (internal or external) and therefore, cannot be completely ruled out. Solactive endeavors to correct all errors that have been identified within a reasonable period of time. The understanding of "a reasonable period of time" as well as the general measures to be taken are generally depending on the underlying and is specified in the Solactive Correction Policy, which is incorporated by reference and available on the Solactive website: https://www.solactive.com/documents/correction-policy/.

3.6. MARKET DISRUPTION

In periods of market stress Solactive calculates its indices following predefined and exhaustive arrangements as described in the Solactive Disruption Policy, which is incorporated by reference and available on the Solactive website: https://www.solactive.com/documents/disruption-policy/. Such market stress can arise due to a variety of reasons, but generally results in inaccurate or delayed prices for one or more INDEX COMPONENTS. The determination of the INDEX may be limited or impaired at times of illiquid or fragmented markets and market stress.

4. MISCELLANEOUS



4.1. DISCRETION

Any discretion which may need to be exercised in relation to the determination of the INDICES (for example the selection of the INDEX COMPONENTS (if applicable) or any other relevant decisions in relation to the INDICES) shall be made in accordance with strict rules regarding the exercise of discretion or expert judgement.

4.2. METHODOLOGY REVIEW

The methodology of the INDEX is subject to regular review, at least annually. In case a need of a change of the methodology has been identified within such review (e.g. if the underlying market or economic reality has changed since the launch of the INDICES, i.e. if the present methodology is based on obsolete assumptions and factors and no longer reflects the reality as accurately, reliably and appropriately as before), such change will be made in accordance with the SOLACTIVE Methodology Policy, which is incorporated by reference and available on the SOLACTIVE website: https://www.solactive.com/documents/methodology-policy/.

Such change in the methodology will be announced on the Solactive website under the Section Announcements, which is available at https://www.solactive.com/news/announcements/. The date of the last amendment of this INDEX is contained in this GUIDELINE.

4.3. CHANGES IN CALCULATION METHOD

The application by the Index Administrator of the method described in this document is final and binding. The Index Administrator shall apply the method described above for the composition and calculation of the Index. However, it cannot be excluded that the market environment, supervisory, legal and financial or tax reasons may require changes to be made to this method. The Index Administrator may also make changes to the terms and conditions of the Indices and the method applied to calculate the Indices that it deems to be necessary and desirable in order to prevent obvious or demonstrable error or to remedy, correct or supplement incorrect terms and conditions. The Index Administrator is not obliged to provide information on any such modifications or changes. Despite the modifications and changes, the Index Administrator will take the appropriate steps to ensure a calculation method is applied that is consistent with the method described above.

4.4. TERMINATION

Solactive makes the greatest possible efforts to ensure the resilience and continued integrity of its indices over time. Where necessary, Solactive follows a clearly defined and transparent procedure to adapt Index methodologies to changing underlying markets (see Section 5.2 "Methodology Review") in order to maintain continued reliability and comparability of the indices. Nevertheless, if no other options are available the orderly cessation of the INDICES may be indicated. This is usually the case when the underlying market or economic reality, which an index is set to measure or to reflect, changes substantially and in a way not foreseeable at the time of inception of the index, the index rules, and particularly the selection criteria, can no longer be applied coherently or the index



is no longer used as the underlying value for financial instruments, investment funds and financial contracts.

Solactive has established and maintains clear guidelines on how to identify situations in which the cessation of an index is unavoidable, how stakeholders are to be informed and consulted and the procedures to be followed for a termination or the transition to an alternative index. Details are specified in the Solactive Termination Policy, which is incorporated by reference and available on the Solactive website: https://www.solactive.com/documents/termination-policy/.

4.5. EXTRAORDINARY TERMINATION

In the event the level of the INDICES are calculated as zero or below zero (negative) the INDICES will be terminated. SOLACTIVE will announce such termination on its website www.solactive.com as soon as reasonably possible after the INDICES is calculated as zero or below zero.

For Clarification, Solactive may terminate indices for other reasons and in accordance with Solactive's policies.

4.6. INDEX COMMITTEE

An index committee composed of staff from Solactive and its subsidiaries (the "INDEX COMMITTEE") is responsible for decisions regarding any amendments to the rules of the INDICES. Any such amendment, which may result in an amendment of the Guideline, must be submitted to the INDEX COMMITTEE for prior approval and will be made in compliance with the Methodology Policy, which is available on the Solactive website: https://www.solactive.com/documents/methodology-policy/.



5. DEFINITIONS

"BENCHMARK REGULATION" shall have the meaning as defined in Section "Introduction".

"BMR" shall have the meaning as defined in Section "Introduction".

"CALCULATION DAY" is every weekday from Monday to Friday where Eurex (MIC: XEUR), New York Stock Exchange (XNYS) and NASDAQ (XNAS) are open.

"CLOSE OF BUSINESS" is the calculation time of the closing level of the INDEX as outlined in Section 1.4.

The "CLOSING PRICE" in respect of an INDEX COMPONENT and a CALCULATION DAY is an INDEX COMPONENTS final regular-hours closing level as calculated by Solactive

"DECREMENT INDEX" is the Solactive Transat Enhanced Exposure EZ Social Screened 50 Decrement 50 EUR Index (ISIN: DE000SL0NQ74)

"ENHANCED EXPOSURE INDEX" is the Solactive Transatlantic Enhanced Exposure EZ Social Screened 50 EUR Index (ISIN: DE000SL0NQ90)

"GUIDELINE" shall have the meaning as defined in Section "Introduction".

"INDEX" shall have the meaning as defined in Section "Introduction".

"INDEX ADMINISTRATOR" shall have the meaning as defined in Section "Introduction".

"INDEX COMMITTEE" shall have the meaning as defined in Section 4.6.

"INDEX COMPONENTS" are the components listed in Section 2.1.

"INDEX CURRENCY" is the currency specified in the column "Currency" in the table in Section 1.2.

"INDEX UNIVERSE" is the sum of all financial instruments which fulfill the INDEX UNIVERSE REQUIREMENTS.

"LIVE DATE" shall have the meaning as defined in Section 1.3.

"SOLACTIVE" shall have the meaning as defined in Section "Introduction".

"START DATE" shall have the meaning as defined in Section 1.3.
