#### Rationale for the Market Consultation

Solactive believes that an adjustment of the withholding tax rates of US-incorporated companies from 30% to 0% for V1 indices and 15% for V2 indices in above table mitigates systematic sources of tracking error.

The objective here is to apply a regional taxation regime more suited to the funds that use financial products based on the indices in this market consultation.

#### Proposed Change to the Index Guideline

The following Methodology change is proposed in the following point of the Index Guidelines:

For the v1 indices defined in the above overview we are proposing to add the below sentence right below the index overview table in the section 1.2. IDENTIFIERS AND PUBLICATION in the respective guideline of each index:

\*For NTR INDICES withholding tax rates applied for US-incorporated companies will be reduced from Solactive Standard rate (listed on the SOLACTIVE website <a href="https://www.solactive.com">https://www.solactive.com</a>) to 0%.

For the v2 indices defined in the above overview we are proposing to add the below sentence right below the index overview table in the section 1.2. IDENTIFIERS AND PUBLICATION in the respective guideline of each index:

\*For NTR INDICES withholding tax rates applied for US Incorporated companies will be reduced from Solactive Standard rate (listed on the SOLACTIVE website <a href="https://www.solactive.com">https://www.solactive.com</a>) to 15%.
