Rationale for the Market Consultation

The Indices are thematic strategies that provide the trend of different themes: Future Cities, Cloud Computing, Extended Longevity, Genomics and Circular Economy. The underlying thematic universes have expanded significantly since the launch of the Indices and the definition of the number of constituents. Therefore, it is not possible to ensure the necessary diversification of the Indices as the concentration in certain sub-segments is too high. Hence, the expansion of the constituents is considered as a needed improvement to the Indices. Increasing the number of constituents would enable to fully capture the theme and represent the thematic universe in the Indices.

Proposed Change to the Index Guideline

The following Methodology changes are proposed in the following point of the Index Guideline (ordered in accordance with the numbering of the affected sections)]:

Proposed methodology change involves increasing the number of constituents in indices listed above. This adjustment aims to better reflect the shifts in their respective industries.
