<b>List of social factors considered</b>	<ul style="list-style-type: none"> <li>&gt; Exclusion of companies violating the United Nations Global Compact</li> <li>&gt; Exclusion of companies involved in the production or sale of anti-personnel landmines, cluster bombs, depleted uranium, and/or chemical/nuclear/biological weapons, regardless of the revenues involved and/or generate more than 3% of their turnover from the production or the sale of conventional weapons and/or generate more than 5% of their sales/revenues from the production, manufacturing, trade, testing or maintenance of white phosphorous</li> <li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues) &gt; 1% in highly oppressive regimes</li> <li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues) &gt; 5% from adult content</li> <li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues) &gt; 10% from alcohol without any responsible policy</li> </ul>
