List of environmental factors considered	> Exclusion of companies violating the United Nations Global Compact
	> Exclusion of companies generating revenues (in proportion to their total revenues) >30% in the area of nuclear energy
	> Exclusion of companies generating revenues (in proportion to their total revenues) >10% in the area of therma coal
	> Exclusion of companies generating revenues (in proportion to their total revenues) >10% in the area of unconventional oil and gas
	> Exclusion of companies generating revenues (in proportion to their total revenues) <40% in the area of natural gas or renewable energy
	> Exclusion of companies with lifecycle greenhouse gas emissions intensity of produced electricity > 408 (gCO2/kwh). If no carbon emissions data is available, energy producers are excluded if the derive >10% of their power production from coal or > 30% of their power production from oil & gas, or > 30% of their power production from nuclear sources.

	> Exclusion of companies involved in the production or sale of anti-personnel landmines, cluster bombs, depleted uranium, and/or chemical/nuclear/biologics weapons, regardless of the revenues involved and/or generate more than 3% of their turnover from the production or the sale of conventional weapons and/or generate more than 5% of their sales/revenues from the production, manufacturing, trade, testing or maintenance of white phosphorous
